Celebrating 50 Years of Service

I am forever grateful for those childhood experiences that gave my life purpose and propelled me into our field. At an early age, I was fortunate to know that I wanted to make a difference in the lives of those with I/DD. I am also eternally grateful to the original families who joined me to start the Edwards Center over 50 years ago. They are the real heroes. The risk takers. The believers in greater possibilities. They believed in a young 30-year-old's dream of creating normalized lives for their children, who, until that time, had been disenfranchised and not deemed worthy of the same rights to education and services that those without disabilities enjoyed. There were hard times in the beginning and times when it seemed we could not go on. Funds were short, public opinion was negative, and roadblocks seemed unsurmountable.

That's when we had to remind ourselves that what we were doing was worth fighting for. Our vision was more significant than the obstacles we faced. Those original families have all passed on to their heavenly homes. Still, their children, grandchildren, and friends have continued to serve on our board, volunteer in our programs, and financially support us. Edwards Center has always been about families, and we continue the legacy of the original families who wanted the assurance that their children would be taken care of after they were gone. I wish they could be here and experience the joy that I have in seeing how we've grown towards our original dreams and improved our services as we have sought the gold standard over the last fifty years.

We have accomplished amazing things. The corporate energy, commitment to the mission, and hard work of so many have brought us to where we are today. Many people have contributed to our growth. We have had four executive leaders, 11 board presidents, numerous board members, and hundreds of staff members and volunteers who have generously given their time, talents, and resources so we can continue to create a positive quality of life for all our participants. I am happy to have been able to be the visionary and cheerleader for 50 years. My passion for what we do and can do has not waned over the years. I wake up daily thinking about how we can be better.

We started our first day program in a little house on TV Highway, rented for \$1 a year from the city of Beaverton in 1970. Our staff were all volunteers until we received our first grant, which allowed us to hire a director and one staff. It's important to remember that family volunteers initiated and staffed our program for several years, and it continues to be one of our most essential resources.

One of the things that sets us apart from other agencies that provide similar services is our Family Support Network. Attend any Edwards Community event, and you will find family members volunteering alongside staff to make the event successful. Vox, Latin for voice, is the name given to the family members representing each of our program entities. Vox Homes meet regularly to give input to leadership about improvements needed in our homes and doing practical things to help our homes: birthday parties, games nights, staff recognition, and holiday surprises. Similarly, Vox Jobs and Vox Day services have family members providing input into those programs. The founding families would be enormously happy to know that the voice of families is still being heard fifty years later.

Another aspect that sets Edwards apart from others providing similar services is our commitment to those who come to live with us. We intend for the resident to continue as a member of our Edwards family and grow old with us. We look forward to each person aging with us and enjoying the deep connections made in our family over time. Three of our original residents are still alive in their 70s, enjoying a good quality of life, having lived with us for 49 years. An active life helps folks age well.

To sustain the quality of life we provide, we need to raise significant dollars each year. You receive this annual report because you donated dollars, services, or volunteer hours to our organization. I ask that you continue to support us and bring your associates, other family, and friends to be donors as well.

Caryl had been quick to adopt a passion for normalization, which was the driving force behind the vision of Jean Edwards and the other founders. Soon the board realized in their search that Caryl had all the important qualities needed to lead our organization. In 1975 Caryl was chosen to take us forward. She grew and honed her skills as a leader and administrator as the Center matured.

Most importantly, Caryl was always able to see the hidden abilities behind our participants' disabilities. She was part of the catalyst creating options for those leaving the institution. She was one a of group of folks in Oregon to create new innovations to meet the needs of our residents leaving Fairview.

Caryl was a tireless advocate at the legislative level and spent a great deal of time in Salem advocating for better services. She was one of the most recognizable names in the state when it came to advocacy for adults with developmental disabilities. Her dedication to this population will be surely missed by the families and agencies she consulted with after her retirement from Edwards.

It is with deep gratitude and sincere appreciation that we say goodbye to Caryl.

His perspective on his job is simple yet profound - "The work that I do is still just life. I like it like that."

For Jim, being a Direct Support Professional is not just a job; it's a calling. He sees himself as an extension of the residents' will, working tirelessly to ensure their safety and well-being. Daily, he strives to empower residents to live their lives to the fullest, celebrating their independence and individuality.

What truly brings joy to Jim's heart is witnessing the residents actively participating in their own lives, embracing the messy moments, and finding laughter in the simple joys of everyday life. He believes in the power of dignity and respect, understanding that sometimes the best way to help is by simply staying out of the residents' way and letting them take the lead.

"What makes me happy is seeing residents actively and unapologetically participating in their own lives. Pouring their own cereal and making a mess of it. Hearing them say 'Uh-Oh' to the sound of Cheerios spilling onto the floor."

When faced with crises, Jim's approach is unwavering - to provide a solid yet calm presence, coupled with compassion and acceptance. He recognizes the importance of being there for individuals in their time of need, offering support and understanding without judgment.

Jim's dedication extends beyond the daily routines, as he invests time and effort in helping residents overcome challenges and achieve personal milestones. Jim's patience and encouragement have led to remarkable transformations from teaching a resident to form complete sentences to encouraging another to conquer physical obstacles.

"A resident did not speak in sentences but only in fragments - a few words at a time. I stressed to him the importance of putting those few words into sentence form. Whenever he spoke, I would model for him a sentence using his words plus the ones he'd left out. I would commonly state my name, then add the words 'I need' or 'I want.' How proud was I the day he said to me, 'Jim Croy, come here. I want to show you something!""

Outside of work, Jim finds solace in nature, often spending time near water and trees, hiking, and enjoying the simple pleasures of life. Far removed from the distractions of modern technology (he has never owned a TV or been on Facebook), Jim finds joy in activities like reading and solving puzzles, embodying a sense of simplicity and contentment in his life.

The story of Jim Croy serves as a testament to the power of compassion, dedication, and selflessness in making a positive impact on the lives of others. His unwavering commitment to the residents at Edwards Center embodies the true spirit of caregiving, reminding us all of the profound difference that one individual can make in the world.



What sets this final home at Edwards Place apart is its dedication to serving individuals who have been on the waitlist for five or more years. Recognizing the pressing need for housing, Edwards Place is committed to making a meaningful impact in the lives of those with diverse abilities. Each construction project builds upon valuable design knowledge and insights gained from previous efforts, ensuring continuous improvement.

Edwards Place takes pride in being the nation's first community to provide a diverse mix of housing options for individuals with intellectual and developmental disabilities (I/DD) and their parents. From cottages and apartments to single-family and group homes, this community creates an environment of togetherness and support, fostering a warm and accepting neighborhood.

Residents benefit from convenient access to the Community Center, where regular social gatherings, workshops, and recreational events occur. This vibrant hub enriches the lives of residents and their families, promoting a strong sense of community. The active involvement of families as dedicated volunteers further strengthens the bond within Edwards Place.

The exceptional partnership between Edwards Center and 4th Avenue Homes, the builders, has been crucial to the success of this unique project. Alison's Journey: Cultivating Fulfillment through Career Crafting

Alison has been working with Edwards Center for many years; during that time, she has participated in many employment-related programs that included a sheltered workshop, small groups, and volunteer work. Each of these work experiences provided Alison with opportunities to build skills, confidence, and independence.

All of this contributed to Alison's recent success of getting her first what she calls her "real job," when she was hired to work at Tanasbourne Veterinary Emergency (TVE) in the laundry room, a job Alison identified as something she enjoyed doing during her career exploration.

I think hearing from those supporting Alison best captures the value and impact a "real job" can have for those who didn't believe it would ever be possible.

"My time working with Alison at TVE has been wonderful. She is focused on her tasks and observant of her surroundings. She is learning to navigate the building and follow her routine. When I asked her what she thought about her new job, she said, 'I like it.' I asked what she liked most about it; she said, 'I like the laundry and the people.' She continues to work on building her relationships with coworkers each day. Alison said yesterday, 'After my vacation, I want to work alone with RH.' I asked, Do you want us to not be here with you as much? Alison replied, 'Yeah. I want to do it myself, and you guys just check on me.' I told her I was proud of her for feeling confident in her work and that we could start stepping back a little more. She folded and put away items with little guidance and raised her hands in the air when I said, 'You did it, whoo-hoo!' I turned around, and her coworker was also raising her hands and saying, 'Good Job, Alison'," said Debbie Sketo, Edwards Lead **Employment Professional.**

Alison learned quickly what she was being taught every day; she listened when staff corrected her on a task she might not have done correctly, and she was observant of the details of her tasks. I love seeing how happy she is to work, and everyone who sees her says hi and tells me how happy they are to have her. They love her personality. When I asked her if she liked her job, she said, "I love it," and jumped up and down and laughed. I asked what she liked best, and she said, "Laundry and the animals."


