THE 19 GROUP HOMES CONTINUED UPGRADES AND MAINTENANCE TO SUPPORT INDIVIDUALS IN A SAFE AND PLEASANT HOME. 24 HOURS STAFF SUPPORT IS PROVIDED WITH REQUIRED RESTRICTIONS AND PROPER SAFETY PROTOCOLS AS DIRECTED BY THE STATE OF OREGON DURING THE COVID-19 PANDEMIC, DURING THIS FISCAL YEAR THERE WAS NO ILLNESS DUE TO COVID-19 IN THE GROUP HOMES. STAFF ALSO SUPPORTS MANY INDIVIDUALS SO THEY CAN LIVE INDEPENDENTLY IN THEIR OWN APARTMENTS.
