THE 19 GROUP HOMES CONTINUED UPGRADES AND MAINTENANCE TO SUPPORT INDIVIDUALS IN A SAFE AND PLEASANT HOME. 24 HOUR STAFF SUPPORT IS PROVIDED WITH REQUIRED RESTRICTIONS AND PROPER SAFETY PROTOCOLS AS DIRECTED BY THE STATE OF OREGON DURING THE COVID-19 PANDEMIC, DURING THIS FISCAL YEAR THERE WAS NO SEVERE ILLNESS DUE TO COVID-19 IN THE GROUP HOMES. THERE WILL BE INCREASED INDIVIDUALS SERVED IN THE NEXT YEAR AS STAFF IS HIRED AND TRAINED FOR THESE PROGRAMS.
